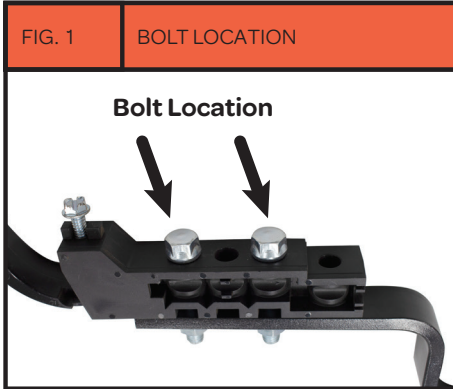


Fig. 1 Leave the first hole empty at the top of the firmer adapter and place the bolts in the 2nd and 4th openings.¹

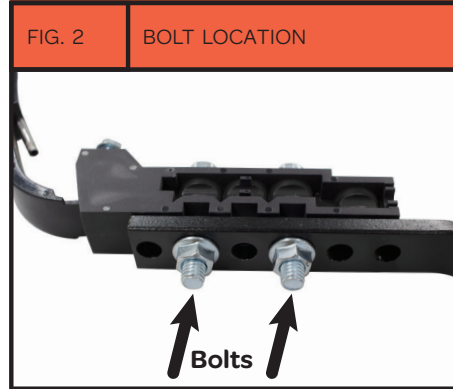


Fig 2 Above highlights the bolt location for Firmer block and S Bar. Connect using 2 Standard Hex Bolts in the 2nd and 4th hole openings.¹

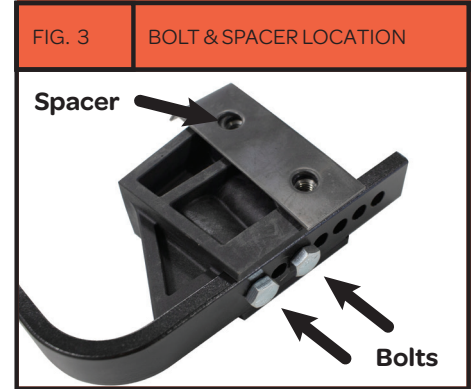


Fig 3 Above highlights the bolt location for Firmer block and S Bar. Place the bolts in the 1st and 3rd hole openings.¹

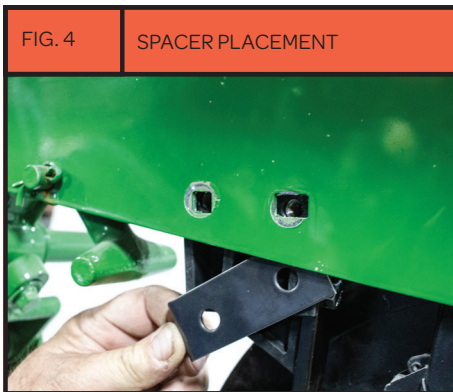


Fig. 4 Place the spacer in between the scraper holes and the firmer block like shown.

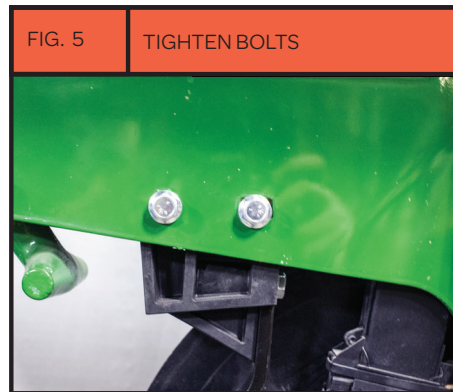


Fig 5 Tighten the bolts to ensure that the spacer and attached piece stay in place.

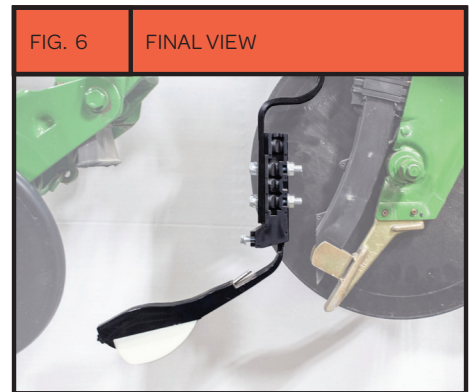


Fig 6 Above shows the final view of the attached piece.
